The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more.

The voltage for a long time storage shall be 3.8V~4.8V range.

The Lithium-ion Battery had been tested according to the requirements of the UN manual of tests and Criteria, Part III, subsection 38.3;

The Li-ion Battery with a Watt-hour rating not exceeding 100Wh or the cell with a Watt-hour rating in not exceeding of 20Wh, The lithium ion batteries according to Section II/Section IB of PACKING INSTRUCTION 965, or Section II of PACKING INSTRUCTION 966~967 of the International Air Transport Association(IATA) Dangerous Goods Regulations 59th Edition may be transported.

The charge state of the sample shall not exceed 30% of the rated capacity when transport.
